Newark's first ever Teenage Market took place on Sunday 19 September. Twelve young entrepreneurs set up stalls in the Wharf, selling wares from sweets, sewing supplies and artwork to homemade jewellery, facemasks and cakes. Taking place alongside the iconic Dragon Boat Race, the market attracted an impressive number of visitors.

The event's success - along with the variety of items on sale and the enthusiasm of the young stallholders - really demonstrated the exciting potential of Newark's youth. We hope to see more of these business superstars in future!

Newark Business Awards



Friday 24 September saw the much anticipated return of the Newark Business Awards – in person once again after last year's virtual event. A huge congratulations to all those nominated – what you've managed to achieve in such a challenging year is nothing short of spectacular. You can find a complete list of winners below.

This year NSDC sponsored the 'Best Start-up' category, recognising the fantastic efforts of new enterprises in the district.

Highly commended in this category was awarded to Back to Life Clinic. Based at Northgate Business Centre, Back to Life Clinic is a Newark osteopathy and sports massage clinic. Its owner, Ian Jenkinson, aims to help everyone who comes through its doors be free from pain and back to being able to enjoy and live life again. Established in March 2019, the clinic was an instant success, attracting twice the number of patients Ian had hoped for.

Beyond Coffee UK was named 'Best Start-up'. Originally beginning in the back of a VW van, Beyond Coffee transformed into a flourishing multifaceted business. After 18 months juggling serving coffee at events and another job, owner Sam Cornfield decided to go full time, opening a coffee and smoothie bar in Fernwood, alongside a pop-up mobile coffee van for events. Two months later, the pandemic struck, yet Beyond Coffee persevered by offering a 'home and workplace' delivery service. With lockdown lifted, Beyond Coffee has gained a wide customer base and presence in Newark.

Upon receiving this award, Sam said: "Very surprised. Can't believe it. There's been a lot of hard work to get to this point, but I still didn't expect it... We now have a number of exciting opportunities coming up, have employed four team members and continue to build our business."



Local energy business providing opportunities for young people



Wilson Energy Limited is one of the UK's leading providers of fully integrated heating, metering, pre-payment and billing & bureau services for residential homes and commercial developments. Originally founded in 2007, Wilson Energy has gone from strength to strength, taking advantage of schemes such as the Think BIG loan fund to expand and improve their customer journey.

As an award-winning local employer, Wilson Energy has dedicated itself to offering young people opportunities, giving them a 'step up' in their career progression. A prime example is their most recent young employee, Josh Tooke, 19 years old, who started working for Wilson Energy in February 2021 in the Maintenance & Support department.

Josh left college in 2020 and was looking to develop his skills in business. His current role includes arranging appointments for engineers, providing top-ups for residential customers, working onsite with some of the meter reading systems, and providing customer quotes for spare parts. Josh says, "The most rewarding part of my job is helping residential customers on a daily basis. I deal with a lot of vulnerable customers, particularly the elderly. These people can be very lonely, and sometimes they haven't spoken to anyone all day, so I will make time to have a chat with them and make sure they are okay".

CEO Andy Wilkinson commented: "Wilson Energy has provided many roles for young people over the years. It is a project which is close to my heart. I want to be able to give young people the chance to help drive them in the right direction of their career paths. It is particularly difficult for young people right now to secure positions that will help to develop their professional skills. It is really rewarding to see many of them who have been successful and gone on to be Directors of companies or to provide them with the confidence to start their own business. As a business, we have also been actively involved with many local schools in the area, providing work experience placements".

Business Resilience Programme

Newark and Sherwood District Council has set up and funded a £300,000 'Business Growth and Resilience Programme.

This scheme offers local businesses support and guidance from professional industry experts to help them in what will be a critical year as the district recovers from the impact of the pandemic.

The programme will link business service specialists with local businesses in four key sectors:

Accomodation



Manufacturing & Construction



Retail, food & beverage



Health & Social Care



Limited

Local businesses within one of these sectors can apply for a 12-16 week programme comprising tailored workshops, 1-2-1 mentoring, business model reviews, training opportunities, and more.

As part of the District Council's commitment to supporting local businesses recovery and growth post pandemic, those who participate in the programme could also be eligible to apply for a discretionary grant of up to £5,000. This grant could be spent by the local business in any way they see fit to boost their recovery and growth.

Advice and guidance from these specialists will help local businesses to adapt, identify new markets or products, develop their plans, modify their ways of working, establish new supply chains, or provide brokerage for skills and training.

For six months, the Government will fund you to provide a job for a young person for 25 hours per week at national minimum wage. For each young person you take on, you will receive £1,500 to support their learning. The deadline for employers to apply for funding for this scheme is 17 December 2021.



Peer Networks



In partnership with CMBD Ltd and PCA Coach, Julie Mather Associates, are now recruiting for the Peer Networks Programme. This scheme is being run on behalf of the D2N2 Growth Hub and begins on Friday, 29 October, and Wednesday, 3 November, 8.30 am-11.30 am.

Peer Networks are a national, peer-to-peer networking programme for SME leaders that want to grow and develop their organisation for future success. Diverse cohorts are made up of up to eleven local entrepreneurs benefitting from group coaching and 1-2-1 support.

From finance and HR to sales, marketing and more, expert facilitators give you the flexibility to create a support network that works for you. You will meet remotely on a regular basis with your cohort and will agree between you what challenges you would like to work through.

This is a fantastic opportunity for any business that would benefit from eighteen hours of group coaching support and 3.5 hours of coaching to help develop a growth plan.

The programme is open to any Derby, Derbyshire, Nottingham, and Nottinghamshire small to medium sized business that has:

- Operated for a least one year
- At least five employees (or lower if a good business case is presented)
- A turnover of at least £100,000 pa
- An aspiration to improve
- The potential to scale up (desirable but not essential)
- The ability or potential to export (desirable but not essential)

This programme is all fully funded. Please see <u>Peer Networks - D2N2 Growth Hub</u> for more information, including eligibility criteria and how to apply.

Export Support Service



The Department for International Trade has launched the new Export Support Service to provide your business with free, bespoke advice on exporting to Europe.

If you are a UK business, you can use this free service, no matter the size of your organisation or which part of the UK you are based.

Ask questions on exporting to new markets, the paperwork needed to sell your goods abroad, and the rules for a specific county where you want to sell your services. The Export Support Service will initially focus on questions businesses have about trading with Europe but may expand to cover more global markets in the future.

Small Business Charter: Help to Grow Management

The Government's Help to Grow: Management programme intends to help senior managers of SMEs boost the performance, resilience, and long-term growth of their business.

This 12-week course costs £750 and is 90% subsidised by the Government. It has been designed to allow participants to learn alongside full-time work.

The in-depth curriculum will help you build your capabilities in leadership, innovation, digital adoption, employee engagement, marketing, responsible business, and financial management.

Facilitated by small business experts from leading business schools, this programme includes online and in person sessions, networking, one-to-one mentoring, and support from experienced industry figures.

Future programmes for East Midlands businesses will be hosted at the University of Leicester from **26 November**, Nottingham Trent University from **30 November** then **20 December**, and the University of Derby from **16 December**, with more to follow.

D2N2 Skills Boot Camps



The D2N2 LEP has been announced as one of several organisations to deliver the national Skills Boot camp programme.

Skills Boot camps are free, flexible courses of up to 16 weeks for adults aged 19 or over who are either in work or recently unemployed. They give people the opportunity to build up sectorspecific skills and fast-track to an interview with a local employer.

The government has developed the programme as part of the Lifetime Skills Guarantee and Plan for Jobs, in partnership with employers, providers and local authorities, to help people develop the skills in demand and get a better job.

D2N2, working with delivery partners and the Greater Lincolnshire LEP, is offering brand new courses, including:

- Coding and software development
- IT, Networking and Infrastructure
- Cyber and system security
- Digital Marketing
